Specifications for Lawn Service Contract**

- 1) Contract runs from May 1, 2026 through December 31st 2026.
- 2) Contractor must maintain his or her own equipment.
 - a. No equipment shall be stored on Fire District property.
- 3) Contractor may not subcontract the work.
- 4) Contractor must provide proof of insurance with minimum of \$1M liability. The Fire District shall be named as an additional insured upon award of the contract.
- 5) All clippings and other debris to be taken offsite for proper disposal. No waste material shall be deposited in the Dumpster or otherwise stored on Fire District property.
- 6) Areas to be maintained:
 - a. Lawn at rear of main engine house (brown building) including inside the generator fence.
 - b. Lawns and other grassy areas around Fire Hall (white building).
 - c. Lawn around the gravel parking lot at the corner of Breigle Lane and Firehouse Lane
 - d. Lawn around the house at 26 Breigle Lane
 - e. Walkways, driveways, parking lots, and any other unpaved property where grass, weeds, and other plant life may be growing in an unsightly manner. Including in front of the 2 bay garage on the end of Firehouse Lane, and between the Firehouse Lane Parking lot and NY43
 - f. Lawn immediately around Old Joe's Quarters.
 - g. Mow inside generator area
 - h. Mow Lawns at 24, 29, 33 and 35 Briegle Lane (empty lots)
- 7) Parameters for mowing:
 - a. Lawns should be mowed weekly.
 - b. Weeds and other unsightly plant life should be trimmed or removed.
- 8) Contact personnel – The following personnel are empowered to contact the contractor, to request additional services, or if the contractor has any questions:
 - a. Fire District Administrator
 - b. Commissioner David Hull
 - c. Commissioner Mike Deutsch
 - d. Secretary Joanne Poirier
- 9) Weed wack (6' around) and trim the brush around the following dry hydrants:
 - i. Sheer Road (near Brookside Garage/Tremonts)
 - ii. Sheer Road at the intersection of Biittig Road

- iii. Pond Hollow Road (Near Glenwood Terrace)
- iv. Thais Road (near Delma Lane)
- v. County Route 55 (just in from Route 150)
- vi. Route 151 (between Timberland Dr and Chamberlain Hill Rd)
- vii. Old Best Road (near intersection of Parker Rd)
- viii. Reichards Lake Road at Town Beach
- ix. Valley Drive (2 within the Patanian Development Forrest Glen)
- x. Parker Road, just in from Barns Road.

10) Provide pricing for add on services for spring clean up and fall clean up as options.
